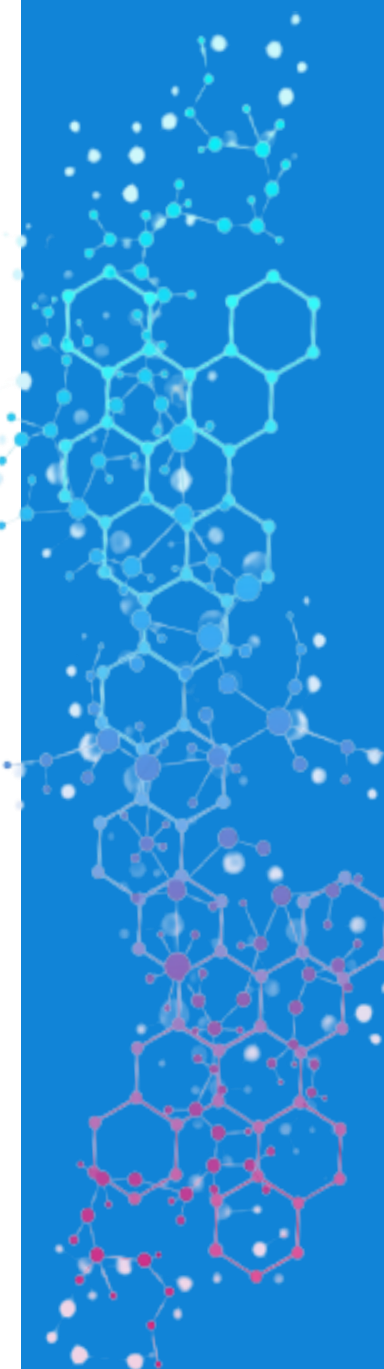

We are driven by a deep sense of responsibility, and therefore we work tirelessly to expand our product range and import innovative medicines that help save lives.

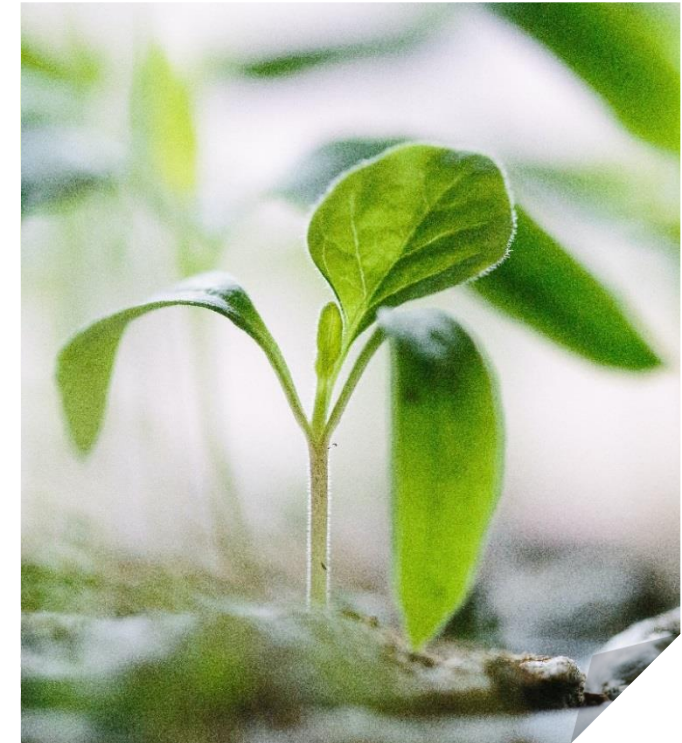
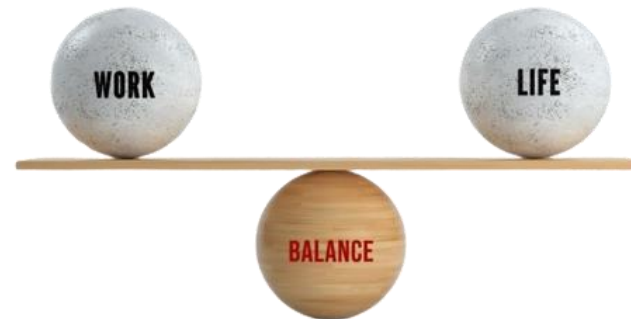

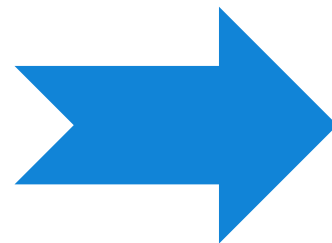
SALES 2016 – 2023
